3. Audited figures of **Quantity produced and sold** for the last year.
4. The rates **should be quoted on per kg basis net** (except for Fresh Milk which would be in liters) **G.S.T. mentioned EXTRA** for each item on F.O.R. basis.
5. Client list and supply for last three years along with proofs.
6. Sample of quality to be supplied (Desi Ghee, WMP) and it's current/latest test report from authentic lab (Preferably Govt.) should be submitted mandatorily with the tender documents.
7. Following tests as per Agmark/FSSAI/BIS parameters or any further testing decided by SGPC would be conducted for each lot supplied whose charges would be borne by the successful tendering firm/supplier.
